HRSA and HHS

Shawnee Health Service (SHS) is a non-profit 501(c)(3) corporation. SHS operates community health centers that are supported by the Health Resources and Services Administration (HRSA) of the U.S. Department of Health and Human Services (HHS) under Grant No. H80CS00667, Project Title: Health Center Cluster. This funding is \$4,744,480 annually; 18% of total operational costs. 82% of operational costs come from patient fees, state and local government, medical schools, foundations, hospitals, and individual tax deductible contributions.

FTCA

Shawnee Health Service (SHS) is a Health Center Program grantee under 42 U.S.C. 254b, and an Federal Tort Claims Act (FTCA)-deemed Public Health Service employee under 42 U.S.C. 233(g)-(n). This health center receives HHS funding and has Federal Public Health Service (PHS) deemed status with respect to certain health or health-related claims, including medical malpractice claims, for itself and its covered individuals.
